

## **1. Outright Bequest**

### **Bequest of a Specific Dollar Amount**

I hereby, give, devise and bequeath \$DOLLARS to Sacred Earth Foundation a 501c3 non-profit organization located at 401 Ekone Road Goldendale WA, Federal Tax ID #26-2272458, for Sacred Earth Foundation's general use and purpose.

### **Bequest of Specific Personal Property**

I hereby, give, devise and bequeath DESCRIPTION OF PROPERTY to Sacred Earth Foundation, a 501c3 non-profit organization located at 401 Ekone Road Goldendale WA 98620, Federal Tax ID #26-2272458, for Sacred Earth Foundation's general use and purposes.

### **Bequest of Specific Real Estate**

I hereby give, devise and bequeath all of the right, title, and interest in and to the real estate located at ADDRESS OR DESCRIPTION OF PROPERTY to Sacred Earth Foundation, a 501c3 non-profit Association located at 401 Ekone Road Goldendale WA 98620, Federal Tax ID #26-2272458, for Sacred Earth Foundation's general use and purposes.

OR

I hereby give, devise and bequeath all of the right, title, and interest in and to the real estate located at ADDRESS OR DESCRIPTION OF PROPERTY to Sacred Earth Foundation, a 501c3 non-profit Association located at 401 Ekone Road Goldendale WA 98620, Federal Tax ID #26-2272458, for Sacred Earth Foundation's Conservation Fund.

### **Bequest of Percentage of an Estate**

I hereby, give, devise and bequeath PERCENTAGE OF YOUR ESTATE to Sacred Earth Foundation, a 501c3 non-profit organization located at 401 Ekone Road Goldendale, WA 98620 Federal Tax ID #26-2272458, for Sacred Earth Foundation's general use and purpose.

## **2. Restricted Bequest**

If you are considering a bequest but would like to ensure that your bequest will be used only for a specific purpose, please let us know.

You may decide to restrict your bequest to support SEF's Conservation Fund, Summer Camp Scholarships, White Eagle Memorial Preserve Burial Need Fund, SEF's Capital Campaign, etc.

We would be happy to work with you and your attorney to help you identify ways to give that will ensure your charitable objectives can be met. We will also work with you and your attorney to craft language to accomplish your objectives.

The simplest recommendation is to substitute your restricted focus description for "general use and purpose" in the final line of any of the above unrestricted bequest language.

If you are making a restricted bequest, we recommend that your attorney include the following provision to give Sacred Earth Foundation flexibility should it no longer be possible to use your gift as you originally intended:

If, in the judgment of the Board of Directors of Sacred Earth Foundation, it shall become impossible for Sacred Earth Foundation to use this bequest to accomplish the specific purposes of this bequest, Sacred Earth Foundation may use the income and principal of this gift for such purpose or purposes as the Board determines is most closely related to the restricted purpose of my bequest.
